

Refunds:

Requests for refund must be received in writing and include a Federal Employer Identification number (if business) or a Social Security number (if individual). Individuals requesting refund must submit their request by mail only, postmarked by September 1st.

Businesses requesting a refund can submit by email to: Dena.Ackors@ks.gov by 4 p.m. September 1st. A \$25 processing fee is withheld from all refunds.

Purchase and Pricing Policies

Payment is required at the time of purchase. You may choose from the following Registration Selections:

Conference Plus Professional Development Class (PDC)

Includes Conference (Tues/Weds), one (1) PDC (Thurs/Fri), light continental breakfasts, Luncheon (Tues/Weds), breaks and vendor reception.

Two-Day Registration (No PDC)

Single-Day Registration (No PDC)
