ORDER TO AMEND

Now, on the 29th day of August, 2016 the above captioned matter came on for consideration before the Public Employees Relations Board.

The Petition for Unit Clarification or Amendment was submitted jointly by the parties, and adds the following position classifications to the bargaining unit: Agricultural Technician Senior, Cook Senior, Electronics Technician Senior, Equipment Mechanic Specialist, Lock System Specialist Senior, Mechanic's Helper, Painter Senior and Veterinary Specialty Technician. The amended unit now includes and excludes the following:


Include: Agricultural Assistant, Agricultural Technician, Agricultural Technician Senior, Animal Science Technician I, Animal Science Technician II, Automotive Driver, Baker, Building System Technician, Carpenter, Carpenter Senior, Cook, Cook Senior, Custodial Crew Leader, Custodial Worker, Custodial Specialist, Electrician, Electrician Senior, Electronics Technician, Electronics Technician Senior, Equipment Mechanic, Equipment Mechanic Senior, Equipment Mechanic Specialist, Equipment Operator, Equipment Operator Senior, Equipment Operator Specialist, Equipment Operator Trainee, Extension Nutritional Assistant I, Extension Nutritional Assistant II, Facilities Specialist, Food Service Worker, General Maintenance and Repair Technician, General Maintenance and Repair Technician Senior, Health Care Assistant, Lab Education Technician, Laboratory Technician I, Laboratory Technician II,

Laboratory Technician III, Lock System Specialist, Lock System Specialist Senior, Machinist, Mason, Meat Cutter, Mechanic, Mechanic Senior, Mechanic's Helper, Painter, Painter Senior, Photographer, Photographer Senior, Plant Science Technician I, Plant Science Technician II, Plumber, Plumber Senior, Power Plant Operator, Power Plant Operator Senior, Printer, Printer Senior, Printer Service Coordinator, Printer Specialist, Refrigeration and AC Service Technician, Refrigeration and AC Service Technician Senior, Sheet Metal Worker, *Service Assistant, Utility Worker, Veterinary Anesthesia Technician, Veterinary Specialty Technician, Veterinary Technician I, Veterinary Technician II, Welder

Exclude: Office, clerical employees, all professional employees, elected and management employees, officials, uniformed police employees, security guards, and supervisory and confidential employees as defined in the Act under K.S.A. 75-4322, and all temporary, student or emergency employees.

Pursuant to the mutual agreement of the parties, it is hereby ordered to adopt the new bargaining unit as previously cited.
