
UNIT: Includes all employees of Kansas Soldiers' Home, with the exclusion of confidential and supervisory personnel as listed on the attached sheet.

and may enter into a written agreement with such employee organization with regard to conditions of employment, and shall meet and confer with such employee organization in the determination of, and administration of, grievances.

Now on this 20th day of July, 1973, the above-captioned matter comes before the Public Employee Relations Board on its regular meeting agenda.

Appearances are: Wayne Garrett, Director, Kansas Veterans' Commission; William F. Morrissey, Attorney for the petitioners.

Thereupon, the attorney for the petitioners files with the Board an amendment to the petitioners' motion for formal determination of an appropriate unit and for elections. There is no objection to said amendment and said amendment is accepted.

Thereupon, the attorney for the petitioners requests a hearing to allow legal argument on the petitioners' motion, as amended, for formal determination of an appropriate unit and for elections herein. There appears no objection to said request by any party to the matter.

Whereupon, the Board takes notice of its decision, issued on the Board's own initiative on this date at this regular meeting, that formal hearings will be held at some date in the future on the question of whether statewide units for Kansas state agency public employees should be established as appropriate.

Whereupon, the Board, by and through its chairman, without hearing, finds that said motion, as amended, should be overruled.

Thereupon, the attorney for the petitioners requests a hearing on the herein alleged appropriate unit.

Whereupon, the Board finds that said request should be held in abeyance and that all matters herein should be indefinitely continued, pending further order of the Board.

IT IS THEREFORE, BY THE BOARD CONSIDERED AND ORDERED that the petitioners' motion, as amended, for formal determination of an appropriate unit and for elections herein is hereby overruled.

IT IS FURTHER BY THE BOARD CONSIDERED AND ORDERED that the petitioners' request for a hearing on the herein alleged appropriate unit be held in abeyance and that all matters herein be indefinitely continued, pending further order of the Board.
