EXCLUDE: All Police Officers above the rank of Sergeant, excluding Sergeant, Lieutenant, Captain, Major, Lt. Colonel, Colonel and Chief

Further, IT IS ORDERED that the above named public employer shall meet and confer with

FRATERNAL ORDER OF POLICE, WICHITA LODGE #5

and may enter into a written agreement with such employee organization with regard to conditions of employment, and shall meet and confer with such employee organization in the determination of, and administration of, grievances.

The Public Employee Relations Board orders that an election be held June 6, 1974 from 6:00 a.m. to 8:00 a.m. and from 2:00 p.m. to 4:00 p.m. at the Detention Rehabilitation Center (DRC) located at 701 West Harry, Wichita, Kansas, for the purpose of determining whether the employees of the appropriate unit want to be represented by: (1) WICHITA ASSOCIATION OF POLICE OFFICERS, NUPO, LOCAL 812, or (2) FRATERNAL ORDER OF POLICE, WICHITA LODGE #5.

We will again need assistance from the employer and employees on the date of the election to provide identification of each eligible employee voting so that their names can be checked off the eligible employee voters list.

The Board allows the public employer one observer and each public employee organization one observer at the polls. All parties are required to be at the polling area by 5:30 a.m. on the date of the election in order for the Board Agent to instruct observers on election procedure.





O R D E R

The above entitled matter came before the Board on April 18, 1974 for determination of the appropriate unit. The Board finds that on March 14, 1974 the Wichita Association of Police Officers, NUPO, Local 812 filed a petition purporting to be for unit determination and certification of certain Wichita Police Officers. The Board further finds that on March 19, 1974 the Fraternal Order of Police Wichita Lodge No. 4 filed their answer in form of a petition for unit determination and certification of said employees.

Answer to petitions was filed by the employer on March 25, 1974 and an amended petition was submitted on April 5, 1974 from the Fraternal Order of Police Wichita Lodge No. 4. The Board finds that no objections to the petitions have been filed, that the time in which to file such objections has expired, and that the unit herein should be determined as set forth in the original petition.

It is therefore ordered that the appropriate unit in this matter before this Board concerning certain Wichita Police Officers shall be as follows:

INCLUDE: All Police Officers and Detectives below the rank of Sergeant

EXCLUDE: All Police Officers above the rank of Sergeant, excluding Sergeant, Lieutenant, Captain, Major, Lt. Colonel, Colonel and Chief
