ORDER

The Kansas Public Employer-Employee Relations Board, has before it a Stipulation for Unit Determination and Certification signed by the Petitioner, International Association of Firefighters, Local 64, and the Respondent, Unified Government of Wyandotte County, Kansas City, Kansas, in the above-captioned action.

WHEREFORE, THE BOARD ORDERS, pursuant to and consistent with the Stipulation for Unit Determination and Certification filed by the partes that the Petitioner be determined to be the exclusive collective bargaining representative for the bargaining unit of "all full-time Wyandotte County Process Servers" employed by the Unified Government of Wyandotte County/Kansas City, Kansas represented by the Petitioner as it relates to the provisions of K.S.A. 75-4321, *et seq.* Further, the Board finds that the petitioned for unit is an appropriate bargaining unit and is fully described as follows:

75-UDC-1-2006

"All full-time Wyandotte County Process Servers employed by the Unified Government of Wyandotte County/Kansas City, Kansas; excluding managerial employees, supervisors and all other employees."

It is further ordered that this Order is dispositive of the pending matter before the Board.


