
ORDER

It is so ordered this 22<sup>nd</sup> day of December, 1989.



STIPULATION

The parties met for Pre-Hearing Conference on December 5, 1989 and pursuant to discussions have agreed upon the following stipulations in settlement of the issue of employees to be included in the proposed employee unit:

1. It is agreed and stipulated the unit shall be composed of all employees in the University Police Officer classification and shall exclude University Police Sergeants, Detectives, all managerial, confidential and supervisory employees, those employees appointed on a student basis, and all other employees not specifically included or provided for by this stipulation.

2. It is agreed and stipulated the positions of University Police Officer, Temporary, Emergency, Intermittent and Seasonal, are not presently being used by Respondent nor is there any intention to employ individuals in those positions at this time except in the case of an emergency situation. For that reason no determination is being made at this time as to whether such employees should be included in this unit and accordingly these positions will not be included within the unit.

3. It is further agreed and stipulated that should Respondent determine it necessary to employ individuals in the positions of University Police Officer, Temporary, Emergency, Intermittent, and Seasonal, Petitioner may petition the Public Employee Relations Board for a determination as to whether such employees should be included in this unit.
