UNIT DETERMINATION ORDER

ON this 19th day of July, 1995, the above-captioned petition for Unit Determination and Certification came on for review. Pursuant to the mutual agreement of the parties that the following classifications should be placed in a Bus Drivers Unit for Unified School District 500, Kansas City, Kansas and there being no statutory violation found in the proposed action, it is determined that the appropriate unit shall be comprised of the following classification:

INCLUDE: All bus-drivers classified as Class I or Class II drivers on the District's Salary Guidelines for Bus Drivers. Class I is defined as "Regular drivers or regular substitute drivers with 0 to 18 months of driving experience with USD NO. 500." Class II is defined as "Regular drivers or regular substitute drivers with 19 months or more driving experience with USD 500."

EXCLUDE: All employees of the public employer except those defined and identified in the above paragraph.
