ORDER

NOW on this 2nd day of February, 1990, comes for review Petitioner's request for a list of names and addresses of the employees in the unit pursuant to K.A.R. 84-2-11(a) (4).

Pursuant to K.A.R. 84-2-11(a) (4) the employee organization is entitled to a list of names and addresses of all eligible employees in the unit upon validation of the showing of interest. Such a validation has been made in the above-captioned matter. Petitioner, therefore, is entitled to such information.

It is general knowledge, both now and at the time of adoption of K.A.R. 84-2-11(a) (4), that the Board does not maintain such lists. Only the public employer would have the name and address information. Obviously if the Board is to provide such a list to the employee organization it must have the means to obtain them from the public employer. Such authority is provided in K.S.A. 75-4323(d) (2) and (3).

Respondent shall file with the Board a list of the names and addresses of all eligible employees in the unit within fifteen (15) days of service of this order. Such list will be forwarded to Petitioner in accordance with its request.

It is understood by the presiding officer that Petitioner has accepted the terms for conducting the certification election in the above-captioned matter and waives any objections to the election based upon a failure to receive those names and addresses prior to the date of the election.


