
UNIT: INCLUDE: University Police Officers including probationary and conditional appointments.

EXCLUDE: University Police Sergeants, managerial, confidential, and supervisory employees and all other employees not specifically included or provided for by the stipulation of the parties.

Further, IT IS ORDERED that the above named public employer shall meet and confer with Kansas Association of Public Employees (KAPE).

and may enter into a written agreement with such employee organization with regard to conditions of employment, and shall meet and confer with such employee organization in the determination of, and administration of, grievances.


ORDER

Further, pursuant to the stipulation of the parties, no determination is made at this time as to whether the positions of University Police Officer, Temporary and Emergency, should be included in this unit.
