O R D E R

The above entitled matter came before the Board on August 15, 1974 for determination of the appropriate unit. The Board finds that on August 1, 1974 Service Employees Union Local 513, AFL-CIO filed a petition purporting to be for unit determination and certification of an employee organization. Further by order of this Board, on August 5, 1974, the public employer had until August 12, 1974 to object to said petition or allegations of said petition would be deemed admitted. The Board further finds that there were no objections to the unit; however by letter of August 8, 1974, the employer stated corrections to items 3, 5, 6a and 8 of the petition. The employee organization answered in agreement to changes, by letter of August 14, 1974.

It is therefore ordered that the appropriate unit in this matter before this Board shall be as follows:

INCLUDE: All street, water, park, sewage and sanitation employees and foremen employed by the City of Russell Public Works Department, *& Custodian*

EXCLUDE: All uniform fire and police, all secretaries, professional, elected officials, supervisors, electric department and cemetery sextant.




IN THE MATTER OF CASE NO. UDC 8-1974c - PETITION OF SERVICE EMPLOYEES UNION LOCAL 513, AFL-CIO FOR UNIT MODIFICATION OF CERTAIN EMPLOYEES OF THE PUBLIC WORKS DEPARTMENT, RUSSELL, KANSAS

The above matter comes before this Board for modification of the appropriate unit. The Board finds that on March 21, 1975, Service Employees Union Local 513, AFL-CIO filed a request for a unit modification of the Public Works Department to include approximately ten (10) employees of the City of Russell Electric Power Plant. Further, that on March 27, 1975, an answer was filed with the Public Employee Relations Board agreeing with the suggested unit modification. Mr. Arthur J. Veach, acting on behalf of Local 513, has furnished this Board with a showing of employee interest in the amount of thirty percent (30%) of the number of employees of the proposed modification unit.


It is therefore ordered that the appropriate unit in this matter before this Board concerning certain employees of the Public Works Department, City of Russell, Kansas shall be as follows:
