O R D E R

It has been determined the appropriate unit in the above case is as set forth in the Board's Order on State-Wide Units dated May 16, 1974, and a thirty percent showing of interest has been received from Local 1469, Kansas Public Employees Union, AFSCME, AFL-CIO; therefore, this Board orders that an election be held on October 30, 1974 from 6:30 a.m. to 9:00 a.m. and from 1:30 p.m. to 4:00 p.m. in the Employees Dining Area of the Larned State Hospital Cafeteria.

This election will be held for the purpose of determining whether the aforesaid employees want to be represented by: LOCAL 1469, KANSAS PUBLIC EMPLOYEES UNION, AFSCME, AFL-CIO, or have NO REPRESENTATION.

We will need assistance from the employer and employee organization on the date of the election to provide identification of each eligible employee voting so that their names can be checked off the eligible employee voters list.

Board rule 84-2-12 allows for observers. The Board allows the employer one observer at each poll and each public employee organization one observer at each poll.


