ORDER

The Kansas Public Employer-Employee Relations Board, has before it a Stipulation for Decertification/Certification signed by the Petitioners, Public Service Employees Union, Local No. 1132, AFL-CIO, American Federation of State, County and Municipal Employees and Local No. 1294 of Missouri/Kansas State Council No. 72, and the Respondent, Unified Government of Wyandotte County/Kansas City, Kansas, to the above-captioned action.

**WHEREFORE, THE BOARD ORDERS,** pursuant to and consistent with the Stipulation for Decertification/Certification filed by the parties that the American Federation of State, County and Municipal Employees and Local No. 1294 of Missouri/Kansas State Council No. 72 be decertified as exclusive collective bargaining representative for the employees of the Transit Department of the Unified Government within the job classification of Transit Caretakers, and that

the exclusive collective bargaining representative as set for in K.S.A. 75-4321, *et. seq.* shall be the Public Service Employee Union, Local No. 1132 and that the new bargaining unit certification is as follows:

The Employer recognizes the Public Service Employees Union, Local No. 1132 as exclusive bargaining agent for employees employed within the Transit Department of the Unified Government within the job classification of Transit Caretakers, except that confidential and supervisory employees within these job classifications are excluded.

It is further ordered that this Order is dispositive of any pending matter relating to these employees.

COME NOW the parties in the above-referenced proceeding, the Public Service Employees Union, Local No. 1132, AFL-CIO, American Federation of State, County and Municipal Employees and Local No. 1294 of Missouri/Kansas State Council No. 72, Petitioners, and the Unified Government of Wyandotte County/Kansas City, Kansas, Employer, and provide the following stipulation to the Public Employer/Employee Relations Board relating to the above-referenced Petition:

1. The Petitioners stipulate that the Unified Government's employees employed within the Transit Department of the Unified Government in the positions of Transit Caretakers, who have been previously represented by American Federation of State, County and Municipal Employees and Local No. 1294 of Missouri/Kansas State Council No. 72 from initial date of certification and that

the parties have stipulated that the American Federation of State, County and Municipal Employees and Local No. 1294 of Missouri/Kansas State Council No. 72 shall be decertified as exclusive collective bargaining representative for these employees and that the Public Service Employees Union, Local 1132 shall be certified as the exclusive collective bargaining representative for these employees of the Unified Government.

2. The Unified Government is in agreement with this decertification and certification of exclusive collective bargaining representative for the designated employees and respectfully requests that the Public Employer/Employee Relations Board enter an order effectuating the stipulation for decertification and certification as set for herein.
