NOW, on this 30th day of January, 2015, the above captioned petition for Unit Representation Election comes on for the certification of a ballot tally for a runoff election conducted by mail. A tally of ballots, attached, was performed on January 23, 2015 at 2:00 PM at the Department of Labor offices at 401 SW Topeka Boulevard, Topeka, Kansas 66603. The parties were not represented. Ballots received by deadline were counted and result was as follows:

**IT IS THEREFORE ORDERED**, pursuant to K.S.A. 72-5419 and K.A.R. 49-25-12, that Garden City Community College shall conduct professional negotiations effective as of February 1, 2015 with the GC3 Educators as exclusive representative of the professional employees' bargaining unit.
